



Thrive Grove Navigation Center

An interim housing solution, Thrive Grove provides a solution that gets people off the street into a dignified, safe space of their own. It is an important missing link in the City of Thousand Oaks' ability to address the rising homelessness issue!

Thrive Grove is a collaboration between the City of Thousand Oaks, Law Enforcement, the County of Ventura, and non-profit organizations that specialize in homelessness services and support, interim housing, and permanent housing.

Thrive Grove Essential Information

- The center will offer 30 beds, with five beds reserved for law enforcement
- An average stay of 3-6 months prepares participants to move into permanent housing with Many Mansions or another Supportive Housing provider
- A modular home village model ("tiny homes") with thirty durable, insulated cabins
- Amenities include administration offices, clinic, laundry and shower facilities, storage, social and dining areas, a dog run, and bike racks
- A trauma-informed design methodology to facilitate a successful program
- 24/7 staff on site, including security personnel, case managers providing wraparound services, and navigation specialists
- Three meals, health services, and transportation provided

Thrive Grove Good Neighbor Policy

To support a positive environment for participants and our neighbors, Thrive Grove will implement a comprehensive Good Neighbor Policy. We commit to:

Ensuring Safety: Security measures are in place, including 24/7 staff and security personnel.

Maintaining Cleanliness: Our team will ensure the shelter and surrounding areas are kept clean and free from litter.

Preventing Loitering:

- Participants will be informed of our **no-loitering rules**. Rules will be strictly enforced.
- **Staff will patrol** the surrounding areas multiple times a day to prevent loitering and ensure cleanliness.
- **Walk-up will not be allowed.** Participants may only arrive and leave with private vehicles or transportation arranged by Thrive Grove or Law Enforcement.

Ongoing Communication & Quick Resolutions:

- We will maintain open communication channels and hold regular community meetings. Phone numbers as well as a complaint form on our website ThriveGrove.org (going live soon) will be available to the public. All issues will be addressed promptly.
- An Advisory Council with members representing the City, County, Law Enforcement, and adjacent businesses and residential communities will review operations and performance, including public concerns.
